#### **RESOLUTION NO. 409-1**

## RATIFYING PREVIOUS WITHDRAWAL OF CERTAIN PARCELS OF REAL PROPERTY FROM 2013 MONROE COUNTY JUDICIAL TAX SALE.

**WHEREAS,** parcels of real property, specifically referenced on the list marked <u>Exhibit A</u> and attached hereto and incorporated as if set forth verbatim herein, were previously scheduled for a judicial tax sale on April 3,2013; and

**WHEREAS,** said parcels are located within the Tellico Village, LLC development, with the exception of one parcel being located within the Rarity Bay community development; and

WHEREAS, the Monroe County Mayor's office is advised that real estate covenants and restrictions apply to said properties through the Tellico Village Property Owners Association, which include a provision for the payment of annual maintenance fees in the approximate amount of Twelve Hundred (\$1,200.00) Dollars annually, and through the Rarity Bay Community Association, Inc. in which Rarity Bay Community Association, Inc. assesses annual maintenance fees; and

WHEREAS, the Monroe County Mayor concluded it was not in the best interest of Monroe County to have these properties sold at the April 3, 2013 judicial tax sale, and the County Mayor accordingly advised the office of the Clerk and Master on April 2, 2013 to withdraw those properties from the list of those offered for sale on April 3, 2013, in order that Monroe County would be under no obligation to bid for the property and thereby have title vested in Monroe County under circumstances where Monroe County could be called upon to assume any responsibility for payment of regular maintenance fees on said parcels.

**NOW THEREFORE**, the Monroe County Commission does this date hereby ratify and adopt and affirm the actions of the Monroe County Mayor and the Monroe County Clerk and Master in the removal of these parcels of real property from the list of those properties offered for judicial tax sale on April 3, 2013, and directs that any judicial tax sale on said properties be deferred pending a resolution of any issue or concern with respect to property owners' maintenance fees applicable to said properties.
